Terms and Conditions

1. These terms and conditions are for all entrants who enter the 'Win a Fonz Arthur Electric Scooter!' ("Promotion"). Participation in this Promotion is deemed acceptance of these Terms and Conditions.
2. The "Promoter" is NPSC Pty Ltd, located at 55 Norton Street Leichhardt, NSW, Australia 2040.

ELIGIBILITY

3. Subject to condition, this Promotion is only open to Australian residents aged 18 years old and older.
4. The following parties are ineligible to enter the promotion: (i) employees of the Promoter, the Colliers Property Group or any of the tenants or retailers in the Participating Centre or any of the Promoter's agencies that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter's promotions.

PROMOTION PERIOD

 5. Winners will be notified within 48 hours of the draw taking place.

LIMITS ON ENTRY

7. Multiple entries can be made per person per day, however all entries must be accompanied by a valid single transaction receipt and be eligible as per promotion Terms and Conditions.

PRIZE

8. The Prize is one (1) Arthur 2, Racer Green (custom) with *Arthur Leather Saddle, Indian Pony and *Arthur Premium Street Tyres Pirelli – total value at \$5,580. Prize does not include registration of the vehicle. The Arthur 2, Racer Green on display, will be the unit handed over to the winner. The Prize must be picked up from FONZ showroom premises in Alexandria, NSW at a date agreed between the winner and Promoter.
